

INDEMNITY AND WAIVER AGREEMENT

FOR MINOR PARTICIPANTS HONG KONG PICKLEBALL LEAGUE (HKPL)

IN CONSIDERATION of the HKPL accepting the minor participant named below (the "Minor") for participation in any HKPL events, leagues, training sessions, tournaments, or related activities (the "Activities"), I, the undersigned parent or legal guardian, hereby acknowledge and agree as follows:

1. ACKNOWLEDGMENT OF RISKS

I acknowledge that pickleball, by its nature, involves physical exertion and inherent risks. I understand that the Minor's participation in the Activities may involve risks of personal injury (including serious bodily injury, paralysis, or death), property damage, and losses, whether caused by the actions of the Minor, other participants, equipment, or the condition of the facilities. I acknowledge that such risks include, but are not limited to:

- Collisions with other players, walls, nets, or fixtures;
- Strenuous cardiovascular activity and musculoskeletal stress;
- Slippery or uneven playing surfaces; and
- The inherent risk of being struck by a pickleball, paddle, or other equipment.

2. VOLUNTARY PARTICIPATION

I confirm that the Minor's participation in the Activities is entirely voluntary. I have advised the Minor of the nature of the Activities and the risks involved. I understand that the Minor is required to adhere to the rules of the HKPL and to conduct themselves in a safe and respectful manner at all times.

3. INDEMNITY AND RELEASE

To the fullest extent permitted by law, I, on behalf of myself, the Minor, my spouse, and my and their respective heirs, executors, administrators, successors, and assigns, hereby:

- RELEASE, WAIVE, AND FOREVER DISCHARGE the Indemnitees from any and all claims, demands, liabilities, costs, expenses, damages, or causes of action (including legal fees) arising out of or in any way connected with the Minor's participation in the Activities, WHETHER ARISING FROM THE NEGLIGENCE OF THE INDEMNITEES OR OTHERWISE, except to the extent caused by the gross negligence or wilful misconduct of the Indemnitees.
- AGREE TO INDEMNIFY, DEFEND, AND HOLD HARMLESS the Indemnitees from and against any and all losses, damages, claims, demands, suits, or liabilities (including legal fees) incurred by the Indemnitees arising from or related to: (a) any act or omission of the Minor; or (b) any breach of this Agreement by me or the Minor.

4. MEDICAL CONSENT

In the event of any injury or illness to the Minor during the Activities, I hereby consent to the administration of first aid, emergency medical treatment, or hospitalisation as deemed reasonably necessary by the HKPL staff or medical personnel. I agree to be financially responsible for any medical expenses incurred as a result of such treatment.

5. USE OF LIKENESS

I grant the HKPL the irrevocable right and permission to photograph, film, or otherwise record the Minor's likeness, voice, and performance in connection with the Activities and to use such media for promotional, marketing, or archival purposes without compensation or further consent.

6. GOVERNING LAW AND SEVERABILITY

This Agreement shall be governed by and construed in accordance with the laws of the Hong Kong Special Administrative Region. If any provision of this Agreement is held to be invalid or unenforceable by a court of competent jurisdiction, the remaining provisions shall remain in full force and effect.

7. ACKNOWLEDGMENT OF UNDERSTANDING

I HAVE READ THIS AGREEMENT CAREFULLY. I UNDERSTAND THAT I AM GIVING UP SUBSTANTIAL RIGHTS, INCLUDING THE RIGHT TO SUE ON BEHALF OF THE MINOR. I ACKNOWLEDGE THAT I AM SIGNING THIS AGREEMENT FREELY AND VOLUNTARILY, AND INTEND IT TO BE A COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY.
